Please read the information in this document, then complete and sign. This form and supporting documents must be turned in to your team Manager or emailed to info@celebrationlittleleague.com by the end of the day on May 4, 2019.

Annually, CLL forms All Star teams to represent the league at end-of-season at All Star tournaments. In order to prepare for the 2019 All Star season we would like to identify all players who are interested in playing in All Stars and who understand the time commitment. Completion of this application process does not assure your child a place on the All Star team. Further, selection to an All Star team is a new process each year. Previous selection to an All Star team does not ensure selection in each successive year. The cost to play on an CLL All Star team is \$100.00, which covers the cost of the uniform (jersey & hat) and the equipment for the team. The jersey and hat are yours to keep at the end of tournament play. Should your player attend EVERY Tournament game, we will refund \$50 at the end of the Tournament.

Commitment

The Little League All Star process requires your full commitment. We need to make sure you are available for all games and practices. Practices begin June 3, and the District tournament concludes in mid-July. If your Division wins the District, the State, and the Regional Championships, play could continue through the middle to end of August. Games could also be daily. If you have scheduled vacations, other sports, camps, or other commitments that will interfere with attendance at practices and games, please explain the circumstances on the back of this form. Absences not disclosed before selection to an All Star team could result in removal from the team.

Playing Time

Players may be asked to play in different positions than they played during the regular season. Minimum play time for a 12-player team is 1 at bat and 2 innings of defense, and for a 13-player team is 1 at bat and no defense. Decisions regarding playing time are in the sole discretion of the Manager.

Forms and Documentation

Certain forms and documents, described in detail on the next page, must be submitted in order for your child to be considered for selection to an All Star team. Little League International is very strict about the required documentation and the dates of the documentation. If not submitted with this Intent Form, documentation will be accepted until May 4, 2019.

In order to play All Stars, each player must submit the following:

- 1. Tournament Player Verification Affidavit
- 2. ORIGINAL Birth Certificate
- 3. Proof of Residence
- 4. Medical Release Form
- 5. Model Release and Waiver

Tournament Player Verification Affidavit

This form is available on the CLL All Stars webpage.

Proof of Residence

All All-Star players must either reside or attend school within league boundaries. Only one of the following proofs is required.

- A. <u>School Enrollment</u>: A player will be deemed to attend school within the league boundaries if the physical location of the school is within the boundaries. A school enrollment form is available on the CLL All Stars webpage which must be signed by an administrator at the player's school. CLL strongly encourages players to use this form.
- B. <u>Proof of Residence</u>: A player will be deemed to reside within the league boundaries if either of the player's parents (or his/her court-appointed guardian) reside within the league boundaries. Parents must provide three proofs of residence, dated or in force between Feb. 1, 2018 and Feb. 1, 2019. Little League has identified three groups, and parents must provide one document from each group. The most commonly used documents are:
 - i. Group I: Driver's License or vehicle records
 - ii. Group II: Child care records, federal tax records, and mortgage or rent records
 - iii. Group III: Utility bills, internet or television records

All documents must be dated within the range above and must clearly show your home address. Financial and other sensitive information should be blacked out. The full list of acceptable documents can be found on the CLL All Stars webpage.

Copy of Birth Certificate

An original will be required if your player is selected to a team. The original will be returned to you.

Medical Release Form

This is a standard Little League form, and it can be found on the CLL All Stars webpage.

Model Release and Waiver

Also found on the CLL All Stars webpage, this form allows Little League to take photos and other images of your player and use those images in appropriate forms. This mostly comes into play if the team advances far enough for games to be broadcast over the internet or on television.
